Construction or improvements required as a result of street improvements include, but are not limited to, infrastructure triggered by the Stormwater Code for work in the right-of-way and drainage conveyance infrastructure (e.g., inlets, catch basins, etc.) triggered by other street improvements.

Prevailing wages were paid for the construction of the water, drainage, and/or wastewater main extension for which SPU is providing funding, as required by the Revised Code of Washington (RCW) [RCW 39.12](#) (Prevailing Wages on Public Works) and [RCW 49.28](#) (Hours of Labor) as amended or supplemented and in accordance with Washington State Department of Labor & Industries, in addition to filing intents and affidavits, keeping payroll records, and submitting certified payroll records if requested.
